- (b) **Discussion and Action on Community Leverage Funding for Downtown Lighting Initiative.** After some discussion Director Packer made a motion to approve the proposal in the amount of \$18,295 contingent upon legal amendments to the contract as stated by Director Hurst and to seek support from downtown businesses in the amount of \$5,000, with the shortfall funded by the City of Marble Falls and the Marble Falls EDC equally. Director Hurst seconded the motion. The motion carried by a unanimous vote (7-0).
