

Contractor Information Packet

The following is a packet of items that must be submitted for contractors to perform work in the City of Marble Falls. Contractor information forms are attached to this packet, can be obtained in office, emailed or faxed. License holder must obtain permit unless special permission is granted otherwise. All information provided must be current, i.e. insurance, license, etc.

1. General requirements for the below listed contractors.
 - Contractor Information Form

 - Proof of Current Insurance

2. Electrical Contractors (License must be issued through TDLR*)
 - Master Electrician License
 - Electrical Contractor License
 - All items stated in section 1.

- 2a. Electrical Sign Contractors
 - Master Sign Electrician License
 - Electrical Sign Contractor License
 - All items stated in section 1.

3. Mechanical Contractors (License must be issued through TDLR*)
 - Refrigeration Class A or B License, Environmental Air Conditions Class A or B, or Combination Class A or B License.
 - All items stated in section 1.

4. Plumbing Contractors (License must be issued through TSBPE*)
 - Master Plumber License
 - All items stated in section 1.

5. Irrigation Contractors (License must be issued through TCEQ*)
 - Landscape Irrigator License; Landscape Installer License
 - All items stated in section 1.

6. Backflow Contractors (License must be issued through TCEQ*)
 - Backflow Prevention Assembly Tester License
 - All items stated in section 1.

7. OSSF* Contractors (License must be issued through TCEQ*)
 - OSSF* Installer (Class I or II) License
 - All items stated in section 1.
